
Dear Workshop,

From 21 August 2023, second-version smart tachographs will be mandatory for all newly registered vehicles in the EU, Switzerland, Norway, Great Britain and Iceland.

VDO has developed DTCO_® 4.1 specifically for this purpose. The new tachograph corresponds to the amendments of Regulation (EU) 2016/799 as set out in Implementing Regulation (EU) 2021/1228. The new tachograph also includes adjustments to the calibration, including the certificate and badge.

Prepare now for the mandatory retrofitting of analogue and digital tachographs (Annex 1B) as well as the smart tachograph version 1, which must be carried out in vehicles operating across borders by the end of 2024 or mid-2025.







Change in periodic inspection with DTCO 4.1

Due to the new functionalities of the DTCO 4.1, the following changes will be made to the periodic inspection:

Functional tests:

GNSS test OSNMA (the check of the new OSNMA functionality is carried out automatically in connection with the already known GNSS test)

- Clock test (Is now mandatory for Annex 1C devices)
- Load type: the standard load type (passenger transport or goods transport) must be programmed in the legal parameters and indicated on the installation plate.
- Test of the indication of the standard load (parameter in the legal parameters).
- Recommendation to test the integrated acceleration sensor
- Recommendation to test the Bluetooth function
- Annex 1C devices must be updateable and, as part of the periodic inspection, any necessary updates must be carried out

(e.g. these are updates for the geo-maps in the DTCO)

This means that it may be necessary to carry out prescribed software updates as part of the periodic inspection.




